## **GENERAL SERVICE SMALL**

## **APPLICABLE**

To all electric service of a single character supplied at one (1) point of delivery and used for general business or commercial purposes, institutions, public or private, and purpose for which no specific rate schedule is provided. This rate is applicable to service of less than twenty (20) kW of demand. If a demand of twenty (20) kW or over is reached three (3) times during a twelve (12) month period, in order to appropriately accommodate a larger load, service will be moved to a tariff with a higher demand limit.

## **CHARACTER OF SERVICE**

Alternating current, 60 cycles; single phase, or three-phase where available, at available secondary voltage.
